All Black Eagle residents are encouraged to decorate their yards for the Red, White, and Blue Contest sponsored by the Black Eagle Volunteer Fire Department.

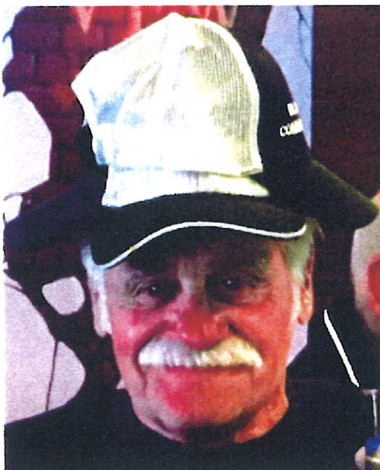

Cascade County Community Dog Ordinance

B. Any dog not wearing an identification tag, or any dog for which the owner or custodian cannot be identified, and which has not been redeemed by its owner or custodian within three days after impoundment, may be adopted upon payment of applicable adoption fees and license fees or disposed of in a humane manner.

Section 14. Nuisance Dogs

It is a public nuisance for any dog to chase vehicles on a county highway or road, to run at large, or to be owned, kept, or maintained without a current immunization against rabies, distemper, and parvovirus.

Every person having under their control any female dog in heat shall confine such dog. Failure to confine such female dog constitutes a public nuisance.

Maintenance, harboring, or keeping of any dog which by loud and continuous barking, howling, or yelping interferes with the comfortable enjoyment of life or property by the community, neighbor, or by a number of persons is also maintaining a public nuisance.

Any dog that destroys property, injures, or destroys other pets or other animals not trespassing on the property of or attempting to injure or injuring the person, family, or property of the owner, is classified as a nuisance.

Any person who allows any dog owned, subject to their maintenance or custody, to be kept in a manner that constitutes a public nuisance, is guilty of a misdemeanor.

Section 15. Impoundment of Dogs Upon Nuisance Complaint.

Any dog constituting a nuisance may be taken and impounded by authorized personnel. It shall be the duty of all authorized personnel for such violations. Any person aggrieved by a nuisance may file a complaint charging the owner with violation of this section.

Section 16. Nuisance Penalties.

Violation of the nuisance section shall be a misdemeanor.

Section 17. Seizure of a Nuisance Dog.

Upon a third conviction under this section of Cascade County Ordinances, or upon a single instance where the facts indicate that such action is necessary for the safety of the citizens of this county or their property, nuisance dogs shall be seized by the Cascade County Sheriff and disposed of in accordance with the impoundment provisions of this Ordinance.

Section 18. Vicious Dogs

Whenever an affidavit is made that any dog has bitten a person and that the person bitten was not attempting to injure the person and that the person bitten was not attempting to injure the person, family, or property owner, the owner of said dog shall be issued a citation therefor, and shall be required to surrender said animal to a licensed veterinarian for quarantine within twenty-four hours after service of citation. Such citation shall be served upon the owner by any person authorized under this Ordinance, or any law enforcement officer, and if the owner cannot be found at their place of residence or located in a reasonable manner, the owner may be served by leaving the citation with a person of suitable age and discretion or by placing it in a prominent place at the front door of such residence of the owner. It is unlawful for any person to refuse or neglect to surrender any such vicious dog within twenty-four hours after service of a citation as provided for in this section.

Upon failure to surrender the dog within twenty-four hours authorized personnel shall forthwith seize and impound such dog at a licensed veterinary office at the owner's expense. In the event the owner is unknown, authorized personnel shall seize and impound such animal without notice.

Section 19. Vicious Dog Behavior Defined.

Any dog, except a dog assisting a peace officer engaged in law enforcement duties, which demonstrates any or all of the following behavior is presumed vicious:

An attack, without provocation, which requires a defensive action by any person to prevent bodily injury and/or property damage in a place where such person is conducting themselves peaceably and lawfully:

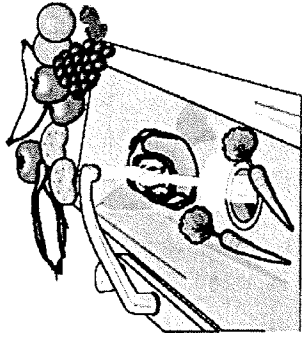
An attack, without provocation, that results in an injury to a person in a place where such person is conducting themselves peaceably and lawfully:

Any behavior, without provocation, that constitutes a physical threat of bodily harm to a person in a place where such person is conducting themselves peaceably and lawfully:

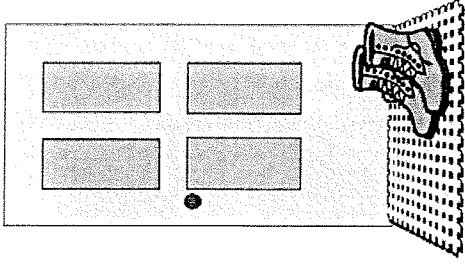
Lawful presence. For the purpose of this Section, a person is peaceably and lawfully upon the private property of an owner when in the performance of any duty imposed upon them by the laws of the State of Montana, or any city or county, by the laws or postal regulations of the United States, or when they are on such property upon invitation express, or implies

Superfund Health Study Findings and More!

County to begin Land Use Planning for the former Black Eagle Smelter Site

EPA's May 11 public meeting provided a thorough review of work accomplished and near-terms plans for the ACM Smelter and Refinery Superfund project. We are currently in the process of developing cleanup design plans for residential areas of Black Eagle and the community park. An assessment of cleanup options will be presented in a Feasibility Study report, which will be completed later this year. EPA will then apply the information to develop a Proposed Plan for conducting the cleanup, which is subject to public review before EPA can publish a Record of Decision on the chosen cleanup option. Detail design and contracting follows, with remediation work scheduled for 2017 if all goes well.

Meanwhile, work has begun to determine initial site investigation needs for the former Smelter Site. In an exciting development, initial discussions with ARCO indicate willingness on their part to consider future site reuse. In support of such efforts, Cascade County is soon to receive a cooperative agreement grant from EPA to develop a land use management plan for the former smelter site, surrounding areas and Black Eagle Park. This effort promises to involve a high level of public support with expert guidance from a landscape architect and land use planning specialist. The goal is to have these plans in place in a timely manner to help bring focus to the kinds of cleanup needed to support future land use.

Scott Sudweeks, toxicologist with the Center for Disease Control, Agency for Toxic Substances Disease Registry (ATSDR), presented on their health assessment. Some key points he made were:

- There is no public health hazard emergency associated with soil contamination in Black Eagle, but about 10 percent of homes should be considered for cleanup under the Superfund program.
- Gardening is not a public health problem; however, minimizing exposure to lead and arsenic contaminated soil is advised. An ATSDR produced insert in the newsletter provides some simple practices that can be used to minimize exposure.
- ATSDR will collaborate with the county, DEQ, EPA and other stakeholders to help develop an institutional control program. This program will likely be health education/awareness based, but may also provide for blood-lead screening and other measures, to be defined as we move through the Feasibility Study process.

"We installed over 270 smoke alarms in Great Falls last October and we are very excited to expand this life-saving campaign in Black Eagle."

Red Cross volunteers can install up to 2 smoke alarms per home depending on need. Volunteers will also check your existing smoke alarm and replace batteries if necessary.

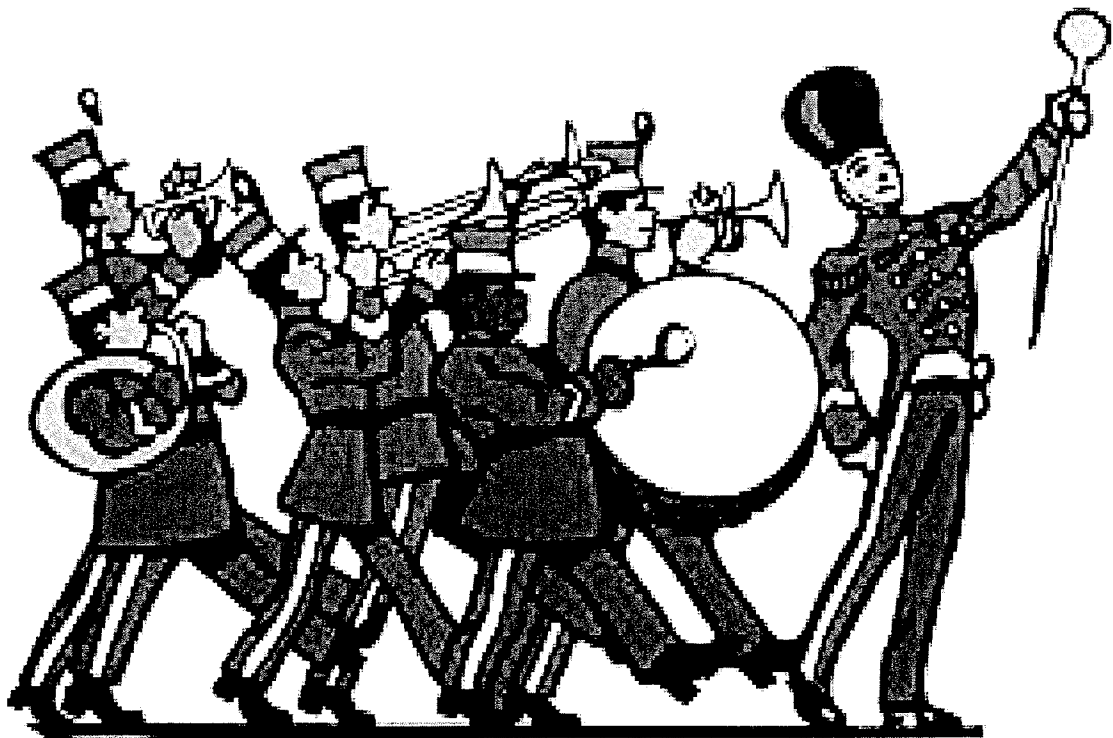

Tips for Keeping Teens Safe on Social Media

More than 60 percent of teens in the United States have at least one social media account, according to the American Academy of Child and Adolescent Psychiatry. And, while being online is a good way to keep in touch with friends, it's important for parents to be proactive about Internet safety.

Unfortunately, there are people who can use your child's personal information to steal identities, bully them or begin an inappropriate relationship. Help protect students from online dangers by following these safety tips:

1. Keep your child's profile private so that only family and people you know can see photos, important dates and other information.
2. Make sure your kids are not posting personal details, including phone numbers, home address, and the name of their school or social security number.
3. Only allow them to publish photos and videos that do not jeopardize their safety or their integrity.

4. Make sure they choose a strong password that cannot be guessed and update the password every three months. The password should be longer than seven characters.
5. Never allow your kids to accept friend requests from people they do not know personally.
6. Keep an open dialogue with your children. Ask them to let you know if they have received private messages from a stranger of from someone at school who is teasing, harassing or threatening them. Those could be signs of cyber-bullying or even a sexual predator. Tell your children they can block or unfriend anyone who is doing one of these things or anyone the child does not feel comfortable receiving messages from. It does not make the child rude or a bad person.
